The application has been considered and the proposal of conversion of such land is allowed from 'Dala, Danga and Dala' to 'College' in the terms and provisions of sub-section 2 of Section 4C of the WBLR Act, 1955. The R.O / BL&LRO / The prescribed Authority is requested to take necessary steps to incorporate in the Record of Right changes affected by such order and to revise the record of rights in accordance with the order after making changes in the fields as per permission u/s 4C.

The change or conversion is allowed with the following conditions:-

- (I) The raiyat shall not violate the provisions as laid down in chapter IIB of WBLR Act, 1955.
- (II) The provisions of Rule-5A/5AA of West Bengal Land Reforms Rules, 1965 shall be strictly followed.
- (III) Such change, conversion or alteration shall take effect from the date of issuance of such order i.e. w.e.f. 09/01/2016 or from the date of making changes in the field.
- (IV) The raiyat shall be liable to pay revenue for such changed / converted class of land.
